Entry Fees:

Pre-entries:

- postmarked **July 1, 2016 – July 31, 2016: \$ 25.00 USD** / class
- postmarked **Aug 1, 2016 – Aug 15, 2016: \$ 35.00 USD** / class
- Pre-entries close Aug 15, 2016 or when limit is filled
- judging is limited to 8 hours per judge per ring

Day before trial entries: \$40.00 USD / class

- taken **Sat. Sept. 10**, between **4 pm to 6 pm**, at the Santiam Building
- accepted only if entry limit has not been reached

Check-in:

Check-in/armband pickup will be at 7:30 am Sun. Sept 11, 2016. Start time for both rings will be 8:30 a.m., beginning with Group Stay Exercises. Classes may be judged later than posted times for each class, but not before the posted start times. Please check into all obedience rings in which you are entered, and notify stewards for all rings in which you are entered if you have conflicts. Crating will **only** be allowed in the designated area of the Santiam Building. No grooming will be allowed in the Santiam Building. ASCA Rules:

This event will be held under the current rules and regulations of the Australian Shepherd Club of America (ASCA[®]). No entry will be accepted from a dog or handler disqualified from all ASCA[®] programs; or a person not in good standing with ASCA[®]. ASCA[®] rules require each dog entered to be ASCA[®] registered. All Obedience dogs must have an ASCA[®] CD before entering Open and have an ASCA[®] Open title before entering Utility.
